How can I register to participate as a virtual shareholder at the NN Group Hybrid Meeting?



As an NN Group shareholder, you will first need to create a profile via www.abnamro.com/shareholder, where you are requested to provide your mobile phone number and custody account number.

Where can I login to participate in the Hybrid Meeting as a virtual shareholder?



You can participate via the ABN AMRO platform and login via www.abnamro.com/shareholder

Can I test if I can get into the virtual environment ahead of the Hybrid Meeting?

Changing your attendance is possible until the Close of Registration, Thursday 8 May 2025 17:00 CEST. As further specified in the convocation of the Hybrid Meeting and as stated on www.abnamro.com/shareholder.

As of which moment can I login to the Hybrid Meeting?



You can login within a time frame of one hour before the start of the Hybrid Meeting. You are counted as a shareholder attending the Hybrid Meeting when you are logged in at the start of the Hybrid Meeting, even if you leave any time during the Hybrid Meeting (whether or not due to an internet connection failure).

How can I follow the Hybrid Meeting?



You will be able to attend the meeting in person or in the virtual environment via <u>www.abnamro.com/shareholder</u> or on the NN Group website.

Can I follow/participate the Hybrid Meeting if I'm not a shareholder?



Yes, you can follow the webcast on the NN Group website.

What do I need to do to participate at the Hybrid Meeting?



You can submit your votes via proxy through ABN AMRO or attend the Hybrid Meeting online and vote electronically or attend in person. In all cases, you must register via www.abnamro.com/shareholder.

When do I need to login when I want to attend the Virtual Meeting virtually and vote electronically during the Meeting?



You will be able to login from one hour prior to the meeting until the meeting starts. The meeting will start at 10:00 CEST on 15 May 2025.

How do I know that I can vote during the Virtual Meeting?



Once the Chair has opened the meeting, you will be able to vote until the Chair declares that the voting will be closed after the last voting item.

How do I know that I have voted at the Hybrid Meeting?



The application will confirm that your vote(s) has/have been received.

Can I ask questions as a virtual participant of the Hybrid Meeting?



Shareholders who are entitled to and wish to ask questions on any agenda item, can submit these in advance of the meeting using the form which can be accessed through the link in the convocation document on the NN Group website, no later than 9 May 2025, 10.00 CEST. Shareholders who registered to attend and vote during the meeting virtually can also ask questions on the agenda items during the meeting via a chat function. The questions that are timely received in advance of the meeting will be answered, possibly thematic, during the meeting and the answers will be available on the Company's website https://www.nn-group.com/investors/general-meetings/annual-general-meeting.htm.

Can I also vote in advance of the Hybrid Meeting?

No, you can't vote in advance of the meeting, however, you can give a proxy voting instruction via www.abnamro.com/shareholder .





No, your proxy voting instruction will remain valid.

If you grant a proxy voting instruction you will only be able to change your voting instruction until Close of Registration, Thursday 8 May 2025, at 17:00 CEST.

How can I change my vote?



You will be able to amend your votes during the meeting, you will be able to vote until the Chair declares that the voting will be closed after the last voting item.





General questions

Why should I choose for online participation when I can grant a proxy voting instruction as I did before?



When you participate online, you will be able to take into account the deliberations (just before and) at the general meeting before you decide how to vote. If you grant a proxy voting instruction you will only be able to change your voting instruction until Close of Registration, Thursday 8 May 2025, at 17:00 CEST.

No. You will be registered on the registration list of all shareholders attending the Hybrid Meeting, in accordance with the provisions of NN Group's articles of association. However, this information will not be provided to other shareholders of NN Group. However, if you would like to ask a question on the agenda items during the meeting you will only be able to do so via chat function. Your name will be visible once you have logged in on the Virtual Attendance Platform to ask questions.

Are my votes valid when leaving early? Can I re-join after I have left?



Yes, assuming you were logged in successfully at the start of the Hybrid Meeting this will not affect the votes casted until the moment you left. Re-joining the Hybrid Meeting after you've left is possible and you will also be able to vote upon items that have been put to vote in the meantime. The polls for all items are open during the Hybrid Meeting and closed after the last voting item on the agenda has been discussed.

When there's a failure in my network connection, or my device stops working during the Hybrid Meeting will I be able to login and continue to participate in the Hybrid Meeting once the connection has been restored?



Yes, assuming you were logged in successfully at the start of the Hybrid Meeting, you will be able to continue participating in the Hybrid Meeting after the network connection has been restored. You will also be able to vote on items that have been put to vote in the meantime. The polls for all items are open during the Hybrid Meeting and closed after the last voting item on the agenda has been discussed.

exercise of rights

Are there any voting restrictions when participating online?



When participating online split-voting is not possible as it is not supported by the platform yet.

I have registered for online participation, but have sold my shares after that. Can I still vote on these shares?



Yes, according to Dutch law the 28th day before the day of the Hybrid Meeting is decisive for who will be able to vote at the Hybrid Meeting. As registration is only possible after that record date, the right to vote remains even if you have already sold your shares in the meantime.

Will the possibility of online participation affect the proceedings at the general meeting?



At the Hybrid Meeting the usual proceedings for general meetings of NN Group will be followed. However, the polls for all items are open during the Hybrid Meeting and closed after the last voting item on the agenda has been discussed.
