

## Jean Frijns new chairman of Delta Lloyd Supervisory Board

The Supervisory Board of Delta Lloyd Group has appointed **J.M.G. (Jean) Frijns** (1947) as chairman of the Supervisory Board with effect from 1 January 2014. He succeeds **R.H.P.W. (René) Kottman** (1945), who will resign from the Supervisory Board on that same date. The succession of René Kottman as a member of the Supervisory Board will be decided at the Annual General Meeting of Shareholders (AGM) to be held in May 2014. A proposal to this effect will be published in good time before the AGM.

René Kottman has a long track record as a Supervisory Board Member within Delta Lloyd Group. He started in 1997 as a member of the Supervisory Board of Nuts OHRA Beheer. When that company merged with Delta Lloyd in 1999, he switched over to the Supervisory Board of Delta Lloyd. In 2006, he became the chairman of the Supervisory Board. At the time of Delta Lloyd's IPO in 2009, he agreed to stay on as chairman of the Supervisory Board for another four years, in order to safeguard the stability in Delta's Lloyd's initial years as a listed company.

Incoming chairman Jean Frijns: "We are grateful for the expertise, solidity, commitment and calm composure that René Kottman contributed as a member of the Supervisory Board in the past 17 years and for the excellent manner in which he fulfilled his role as chairman of the Supervisory Board. René had a great contribution in the creation of the Group during the merger between Delta Lloyd and OHRA, the relationship with the British former majority shareholder Aviva, the IPO in 2009 and the solid manner in which Delta Lloyd is currently navigating its way through the crisis. I consider it a privilege to take over from him as chairman."
